RESOLUTION NO. T-21-1124-01

A RESOLUTION DETERMINING THE AMOUNTS OF MONEY, EXCLUSIVE OF DEBT SERVICE AND ELECTION COSTS, ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION PURSUANT TO THE PROPOSED LEVY OF THE NAPERVILLE TOWNSHIP FOR THE LEVY YEAR 2021, COLLECTIBLE IN 2022

WHEREAS, the Naperville Township ("Township") is a unit of local government operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 et seq. (the "Township Code"); and

WHEREAS, the Township is subject to the Illinois Truth in Taxation Law, 35 ILCS 200/18- 55 et seq. (2013) (the "Truth in Taxation Law"), which law requires taxing districts to disclose by publication and to hold a public hearing on their intention to adopt an aggregate levy in an amount more than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the truncing district prior to such extension, upon the final aggregate levy of the preceding year; and

WHEREAS, Section 6-134 of the Illinois Highway Code, 605 ILCS 5/1-101, *et seq.*, provides that after a road district is abolished, pursuant to passage of the applicable referendum, the township board of trustees, *inter alia*, shall assume all taxing authority of a township road district abolished under [Section 6-134], 605 ILCS 5/6-134; and

WHEREAS, the Truth in Taxation Law requires that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each taxing district shall determine the amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE NAPERVILLE TOWNSHIP, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: The recitals contained in the preamble to this Resolution are hereby incorporated into this Resolution if said preambles were fully set forth within this Section One.

SECTION TWO: The amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation, including for road purposes by the Naperville Township Road Department (formerly the Naperville Township Road District), by the proposed levy of the Naperville Township for the levy year 2021 is estimated to be **\$3,629,420.06.**

SECTION THREE: A public hearing on the proposed 2021 aggregate levy of the Township shall be held on December 14th, 2021, and the Township Clerk shall cause notice of said hearing to be published, all in accordance with the Truth in Taxation Law.

SECTION FOUR: This Resolution shall be in full force and effect from and after its passage as provided by law.
