Trustee Wentz stated that the decision made by Supervisor Vician was not done properly or correctly.

Supervisor Vician stated that Naperville Township historically sent out 3 newsletters out each year. He further stated that he was acting within his limits of power because funds were available under the line item within the Supervisor's Budget.

Supervisor Vician further stated that he was the first Supervisor to include involvement of the Trustees. He stated that there is a NEED to publish a newsletter to inform the public of the services of the township.

Supervisor Vician stated that Trustee Wentz was acting outside the scope of his power when his inappropriate action canceled the scheduled newsletter in 2011 and when he asked employees of Naperville Township to work on his personal political campaign.
