Informational brochures and a cd was disturbed to the board for additional review.

 Supervisor Ossyra provided a redline copy of proposed handbook and relayed that she had been working with all divisions to finalize proposed changes.
- Discuss Naperville Township Publications, Inc. (NTPI) Reinstallment. Supervisor Ossyra presented options available with feedback from Township Counsel Andrew Paine. Option 1 Reinstatement-might be hard to do because only one of the current officers are still Elected Officials with the Township. Option 2 start new. Trustee Anderson if there were any other potential partners like 360 Youth Services or Loaves and Fishes. Counsel Andrew Paine did not think this would be a viable option at this time.
- 12.4 Discuss Proposal for Groot Township Solid Waste Hauling Service Agreement Amendment. Trustee Wegner asked if there was any other bids. Highway Commissioner Wojtasiak made comment to the good job Groot has done. Trustee Malm agreed with the reasonable increases. Ossyra and the Board felt after presentation from Groot Industries the Amendment would be acceptable.
- Discuss Non-Binding Resolution Advising Concerns about Impact of Proposed Medical Marijuana Facility in Naperville Township. Trustee Wegner gave an over view of his findings and his concerns which included; can we put more restrictions on locations, would we be able to show harm to our residents, and that schedule 1 drugs cannot be dispensed. Supervisor Ossyra referenced a letter from Karen Jarsic of 360 Youth Services on this topic. Trustee Anderson also stated that we should use 360 Youth Services as a resource on this issue.
