**RE: Formal Request to Commence Proceedings – 30W326 Claymore Lane**

Dear Chairman Cronin & Members of the DuPage County Board:

On behalf of the Naperville Township Board of Trustees (the “Township Board”), I am writing to request that the DuPage County Board (the “County Board”) commence proceedings with respect to the property located at **30W326 Claymore Lane, Naperville, Illinois 60563** (the “Property”), which is within the Township but outside the territory of any municipality, pursuant to Section 85-50 of the Township Code, 60 ILCS 1/85-50.

This correspondence shall serve as the “formal request” by Naperville Township (the “Township”) to the County Board, as required by statute. On **June 12, 2018**, the Township Board voted to make this request and initiate this process.

The subject Property is semi-abandoned, in a state of disrepair, littered with garbage, and emanates strong, noxious odors. It is believed that other health and safety hazards may be found within the structure, the overall integrity of same is currently unknown. The Township has previously requested that the Property Owner(s) make immediate repairs, but the Township has not received any response. Nor has the Township received a response from the mortgagee, to whom a copy of said request was sent. The Township is seeking swift and definitive resolution for the general health, safety, and welfare of neighboring Township residents.

Pursuant to Section 85-50 of the Township Code, before the Township can pursue action in the circuit court, this County Board must first consider whether to commence specific proceedings against the Property in accordance with Section 5-1121 of the Counties Code, 55 ILCS 5/5-1121. Should the County Board decline taking action, the Township is more than willing to commence same. The Township requests that notice any declination of action (or commencement of action) by the County Board be given to the Township Board in order to effectuate the swiftest resolution to this matter as possible.
