**RESOLUTION NO. T-18-1119-01**

A RESOLUTION DETERMINING THE AMOUNTS OF MONEY, EXCLUSIVE OF DEBT SERVICE AND ELECTION COSTS, ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION PURSUANT TO THE PROPOSED LEVY OF THE NAPERVILLE TOWNSHIP FOR THE LEVY YEAR 2018, COLLECTIBLE IN 2019

**WHEREAS**, the Naperville Township ("Township") is a unit of local government operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 et seq. (the "Township Code"); and

**WHEREAS**, the Township is subject to the Illinois Truth in Taxation Law, 35 ILCS 200/18- 55 et seq. (2013) (the "Truth in Taxation Law"), which law requires taxing districts to disclose by publication and to hold a public hearing on their intention to adopt an aggregate levy in an amount more than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the trucing district prior to such extension, upon the final aggregate levy of the preceding year; and

**WHEREAS**, the Truth in Taxation Law requires that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each taxing district shall determine the amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE NAPERVILLE TOWNSHIP, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION ONE:** The recitals contained in the preamble to this Resolution are hereby incorporated into this Resolution if said preambles were fully set forth within this Section One.

**SECTION TWO:** The amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation by the proposed levy of the Naperville Township for the levy year 2018 is estimated to be **\$1,894,989.38.**

**SECTION THREE:** The amount of said estimated, levy year 2018 is a reduction of the amount of property taxes extended or estimated to be extended from the previous year, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy of the preceding year

**SECTION FOUR:** This Resolution shall be in full force and effect from and after its passage as provided by law.

### RESOLUTION NO. R-18-1119-01

A RESOLUTION DETERMINING THE AMOUNTS OF MONEY, EXCLUSIVE OF DEBT SERVICE AND ELECTION COSTS, ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION PURSUANT TO THE PROPOSED LEVY OF THE NAPERVILLE TOWNSHIP ROAD DISTRICT FOR THE LEVY YEAR 2018, COLLECTIBLE IN 2019

**WHEREAS**, the Naperville Township Road District ("Township Road District") is a unit of local government operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 et seq. (the "Township Code"); and

**WHEREAS**, the Township Road District is subject to the Illinois Truth in Taxation Law, 35 ILCS 200/18- 55 et seq. (2013) (the "Truth in Taxation Law"), which law requires taxing districts to disclose by publication and to hold a public hearing on their intention to adopt an aggregate levy in an amount more than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy of the preceding year; and

**WHEREAS**, the Truth in Taxation Law, requires that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each taxing district shall determine the amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE NAPERVILLE TOWNSHIP, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION ONE:** The recitals contained in the preamble to this Resolution are hereby incorporated into this Resolution if said preambles were fully set forth within this Section One.

**SECTION TWO:** The amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation by the proposed levy of the Naperville Township Road District for the levy year 2018 is estimated to be **\$1,525,777.84.**

**SECTION THREE:** The amount of said estimated, levy year 2018 amount is less than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy of the preceding year

**SECTION FOUR:** A public hearing on the proposed 2018 aggregate levy of the Township Road District shall be held on December 11th, 2018, and the Township Clerk shall cause notice of said hearing to be published.

**SECTION FIVE:** This Resolution shall be in full force and effect from and after its passage as provided by law.

**ADOPTED** by the Supervisor and Board of Trustees of the Township of Naperville, DuPage County, Illinois this 19<sup>th</sup> day of November 2018, pursuant to a roll call vote, as follows:
