LEVY YEAR 2020, COLLECTIBLE IN 2021**

**WHEREAS**, the Naperville Township (“Township”) is a unit of local government operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 et seq. (the “Township Code”); and

**WHEREAS**, the Township is subject to the Illinois Truth in Taxation Law, 35 ILCS 200/18-55 et seq. (2103) (the “Truth in Taxation Law”), which law requires taxing districts to disclose by publication and to hold a public hearing on their intention to adopt an aggregate levy in an amount more than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy of the proceeding year; and

**WHEREAS**, the Truth in Taxation Law requires that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each district shall determine the amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE NAPERVILLE TOWNSHIP, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** The recitals contained in the preamble of this Resolution are hereby incorporated into the Resolution if said preambles were fully set forth within this Section One.

**SECTION 2:** The amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation by the proposed levy of the Naperville Township for the levy year 2020 is estimated to be **\$2,050,000.00.**

**SECTION 3:** The amount of said estimated levy year 2019 property taxes is **an amount less than 105%** of the property taxes extended or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy from the preceding year.

**SECTION 4:** This Resolution shall be in full force and effect from and after its passage as provided by law.


